Deputy Mayor Baryluk inquired about the timeline for water pressure testing at the pool, which had been delayed last month. SAO Hood advised that pressure testing had been completed and that staff may have isolated a problem area in the concrete in the lazy river area. He added that the pool drawings on file do not match the physical construction. At this time, the plan is to blow hot air into the piping and use an infrared heat gun to detect remaining leaks. He also stated that he would be in contact with the Town's contractor for an update on a part that has been ordered.

Item #8

NEW BUSINESS

8.1 RFCD 2019-SAO-001 ~ FD.004 ~ Firefighter Personal Protective Equipment Steel Toe Footwear Policy

Councillor Solotki declared a conflict of interest and left the chambers during both meetings. Director Hammond gave some background on the policy, noting that under employment law, even though firefighters are not employees, they are still considered workers under WSCC and should have steel toed footwear. It was noted that although firefighter bunker gear footwear is steel toed, firefighters do not always wear it during practice or when conducting inspections. Director Hammond confirmed that the policy would cover a single purchase and that footwear would be left at the fire hall. Councillor McBride inquired if the policy contained a clause stipulating that the Town would cover replacing the footwear if damaged. Director Hammond stated that the policy did not specify this but confirmed that the Town would cover replacement due to damage.

8.2 <u>RFCD 2019-SAO-002 ~ Inuvik Water Treatment Plant Heat Supply Agreement</u>

SAO Hood advised that Northwest Territories Power Corporation supplies heat via a glycol loop from their power plant that tempers the intake water at the water treatment plant on an as required basis. He noted that the original 13 year agreement signed in 2001 at a cost of \$40,000.00 per year was part of the Town's takeover of the water treatment plant. Following the expiration of that agreement, a new 3 year agreement was signed and the Town was invoiced for metered heat that was supplied.

After recent negotiations, NTPC reduced its proposed new rate for heat from an 87% increase to 24% over what was being paid, or \$35,000.00 in additional cost per year. SAO Hood stated that the cost is on an as used basis and at this time, the Town does not have an alternate means to heat the water. He added that staff has been looking into alternatives and available funding sources.

Deputy Mayor Baryluk inquired if Administration had been able to confirm if the Town is bound by the formula's cost factor amount. On Wednesday, SAO Hood stated that he had e-mailed a contact at NTPC but had not received a response from them by meeting time.

Councillor Wood stated that the Town should be aggressively pursuing other options and that he was fed up with being held hostage by NTPC. Councillor Wainman inquired about what other options were being researched. SAO Hood confirmed that staff has been looking into installing a biomass boiler at the water treatment plant that could burn wood pellets as well as other types of waste. He noted that funding is available from the Arctic Energy Alliance, GNWT and FCM's green fund.

Councillor MacDonald stated that there is essentially no cost for heat that comes from NTPC's diesel generators, and that it is only when they run the natural gas boilers that they incur a cost. He inquired if there was a way to separate the two sources and meter it that way. SAO Hood stated that as he understood it, the meter is on the glycol line itself. Some discussion followed on whether or not the Town could install its own meters on the lines coming from the diesel and natural gas generators.

SAO Hood stated that the Town requires the heat for water tempering and that the contract has a cancellation clause with 6 months' notice.

Councillor Wainman stated that a water tempering system was missed when the new water treatment plant was built and that it was unfortunate that the Town is running into more costs on a project that was already over budget. Councillor Wainman stated that he hoped finding an alternative solution for next year was a top priority for staff.

Keeping the contract in place as a redundancy was briefly discussed.

SAO Hood stated that it would be difficult to take on running the ski club with our current staffing levels and that more information would be needed in order to determine how many hours and what skills would be required. He noted that the Town does provide the property tax-free.

Deputy Mayor Baryluk noted a piling poking up in the field on the corner of Reliance Street and Inuit Road. On Wednesday, Council was updated that the piling had been removed.

Councillor MacDonald inquired if there had been any follow up to the letter sent to the GNWT about chip sealing Marine By-pass Road. Mayor Kulikowski stated that she had not received a response. It was noted that the item was marked complete on the action items due to the fact that the letter had been sent. Mayor Kulikowski stated that the Town will have an opportunity to speak with Cabinet at the Northwest Territories Association of Communities annual general meeting next month. Councillor Wood reminded Council that the third and final call for resolutions for that meeting has been sent out. SAO Hood stated that Administration has been discussing resolutions and will present them at the next set of Council meetings for approval.
