## Item # 4 DELEGATIONS, PRESENTATIONS OR PETITIONS

## 4.1 RCMP Report

Cpl Woodcock gave an overview of detachment activities in April. He stated that members continue to be involved with youth, noting participation in East Three School's career fair and Children First Centre's on the land program. He advised that one person was charged under the Cannabis Act for having an open container of cannabis that was accessible to the driver.

Deputy Mayor Baryluk stated that it was good to see the public contacting the RCMP about drug possession and trafficking. Cpl Woodcock stated that the successful drug seizures and charges have largely been due to tips from the public.

# 4.2 Tony Devlin, Executive Director, Inuvik Youth Centre Kiosk Mural Project in Chief Jim Koe Park

Mr. Devlin advised that the Inuvik Youth Centre had engaged a youth group from the Yukon to complete a mural project on the Town's kiosk building in Chief Jim Koe Park this summer. He advised that the Youth Centre had received funding last year for a project that was not spent and that when the Town put out a call for artists, he approached the Town about the project. He stated that local youth would be involved in the design process and that the official unveiling was scheduled for June 21. He advised that the group would be arriving on May 29 and were starting things off with a planning meeting to discuss design ideas and that the painting was expected to be completed within a week. He added that the Town logo would be stenciled on all 4 sides of the building to assist with promoting the Town on social media.

## 7.1 Action Items List

Mayor Kulikowski gave brief updates on several items:

<u>Lobby for Re-establishment of Military Base in Inuvik</u>: Mayor Kulikowski stated that she felt the item should be discussed further prior to drafting any correspondence.

Lottery Regulations: The committee meeting was scheduled for May 23.

<u>Environmental Stewardship Committee</u>: Set a target date of June 30, 2019 for moving forward with establishing the committee

<u>Temporary Food Establishment Permits</u>: There has been no response from either Minister. <u>Self Government Update</u>: Due to travel commitments, this item was deferred to a later date.

Cannabis Legislation: This item was deferred to June.

<u>Chief Jim Koe Park Redevelopment Project</u>: There have been no further updates from the GNWT.

Deputy Mayor Baryluk inquired what the engineering costs were for the Breynat Street redevelopment project. SAO Hood advised that the estimated cost is \$103,000 and that Administration has budgeted \$125,000.

## 2019 Final Operating & Capital Budget

SAO Hood briefed Council on changes from the interim budget passed in December 2018. He advised that due to a billing error by NWT Power Corporation, the Town was required to increase property taxes by 2% this year. Deputy Mayor Baryluk commended staff for the work done and stated that he was comfortable approving the budget as presented. Councillor McBride stated that he approved of having a smaller tax increase now rather than being forced to impose a larger increase later.

Mayor Kulikowski noted that the Town will be making a concerted effort to use the full name of Chief Jim Koe Park in all written and verbal communication.

Deputy Mayor Baryluk noted that Camsell Crescent playground sustained some damage over the winter. SAO Hood advised that staff had started its annual parks and trails inspections.

Deputy Mayor Baryluk relayed concerns about the dusty conditions on Airport Road causing safety issues, near misses and very poor visibility. Administration was asked to relay the concern to the Regional Superintendent of the Department of Infrastructure.

Councillor MacDonald requested that the Town remind drivers to slow down when passing pedestrians and people riding bicycles.

Councillor McBride inquired how many of the taxi permits in circulation were Town-owned and asked if these permits were leased or if drivers were charged any fees. SAO Hood confirmed that the Town-owned permits were not leased and that they could not be transferred without the Town's permission. He was unable to confirm the exact number of Town-owned permits in circulation. Councillor McBride stated that removing Town permits from circulation could be a way to address Councillor Wood's concern about having too many permits.
