# Item # 4 DELEGATIONS, PRESENTATIONS OR PETITIONS

# 4.1 <u>Michael McLeod, MP Northwest Territories</u>

MP McLeod gave an update on federal funding assistance provided to the territory and residents since the beginning of the pandemic as well as some indications about what may be included in the upcoming 2021 federal budget.

Prepared questions from Council were:

- 1. What is the expected impact of federal Covid-19 spending over the next 2-5 years?
- 2. Will federal funding be available for northern research as it has been in the past?
- 3. What is the plan for federal military presence in the north and how will Inuvik be impacted?
- 4. Will the federal gas tax funding continue and is 2021 considered an index year?

In response to questions, MP McLeod advised that federal stimulus funding of between \$70-100 billion has been identified, although spending areas have not yet been identified. He stated that he expected federal funding for research would continue but was unable to confirm. He advised that Canada's Department of National Defence has been working hard to modernize NORAD in collaboration with the United States and that ships and frigates are being built, and submarines acquired to defend arctic sovereignty. He added that he would continue to stay involved in future military discussions and developments.

MP McLeod mentioned that the federal gas tax funding has seen an increase nearly every year and that the NWT Association of Communities had made a presentation to the Government of Canada's finance committee expressing its support of the continuation of the program.

Councillor Wood thanked MP McLeod for his work on the Arctic and Northern Policy Framework and expressed the need for an addictions treatment facility in the North, mentioning that funding had been cut several years ago, effectively closing the treatment facility that existed in Inuvik. MP McLeod stated that the Arctic and Northern Policy Framework he envisioned would be a mechanism for federal government funding to flow more easily and directly to the territory. He stated that the pandemic has made the North's challenges and deficits even more apparent. He expressed his support of the concept of a northern treatment centre and mental health supports and acknowledged that partners would be needed to make that happen. He confirmed that the GNWT would continue to support making southern addictions services available to northerners.

Mayor Kulikowski thanked MP McLeod for attending.
