#### **TOPIC**

### **Results of Survey for Taxi Fare Increase**

#### **BACKGROUND**

As per the Passenger Transportation By-law, the taxi companies can put forward a request for a fare adjustment to schedule "C" of the by-law which they have. Council requested that Administration gather feedback from residents before a decision to increase the fares was made. Administration created a digital survey that asked if they were an Inuvik citizen and requesting comments on the proposed increases

Advertisement was made via electronic media including our email subscription service, website, and Facebook. Below is a summary of the information from the survey.

- -136 responses to the survey
- -55 people agree to a smaller increase
- -33 people did not specify if they agreed or not (some comments were blank, some were about concerns for the level of service and some were complaints about previous experiences etc.)
- -27 people agree with the new rates as presented
- -21 people did not agree at all

Attached is a comparison chart of Schedule 'C" from the by-law with the current rates and the proposed rates from the Taxi companies and suggested rates based on information from the survey to the best that can be analyzed.

#### **FINANCIAL IMPLICATIONS**

There are no financial implications for the Town operations.

#### STRATEGIC PLAN OR PRIORITIES CHART IMPLICATIONS

This item is not on the strategic priorities plan or chart.

#### OTHER CONSIDERATIONS OR OPERATIONAL IMPACTS

The last fare increase was in 2014. Given the current economic climate regarding inflation and thus the rise in operational costs a fare increase is probably warranted. This document is being brought forward for discussion by Council. Areas where some consideration should be made is the costs for additional persons, costs for transportation to areas outside the main Town core and the cost involving to or from the airport.

As noted in the options section, Council may adjust any of the fees as they see warranted. Should Council decide on revised fees an amendment to the by-law could be brought forward under the by-law agenda section at the January 11, 2023 Regular Council Meeting. And not under New Business.

#### **OPTIONS**

Council has four options:

- 1. Accept the proposed increases shown in the comparison schedule "C" by the Taxi Companies and amend the Passenger Transporation By-law provide direction to Adminsitration to bring forward the amendments to the by-law at the January 11, 2023 Council meeting
- 2. Modify the proposed increases in scheduke "C" and amend the Passenger Transporation By-law and provide direction to Administration to bring forward the amendments to the by-law at the January 11, 2023 Council meeting
- 3. Not make any changes to the by-law
- 4. Defer the item with direction to Administration on how to proceed

#### RECOMMENDATION

Committee of the Whole recommends the amendments to the Passenger Transportation by-law as per agreed upon an amendment to schedule "C" be brought forward to the January 11, 2023 Regular Council Meeting

2022-12-19-007	I recognize that rates of everything has increased; however, 50\$ to the airport is absolutely ridiculous, as well as to charge per child. How much more weight does one child add to the vehicle? How does that affect the consumption of gas?
	As it is, a round trip to school would be anywhere from 12 to 24\$ a day at lunchtime - parents can't afford this. If you go for groceries, and are already spending upwards of hundreds of dollars, this is just another added expense.
	I can absolutely see the need to increase but an almost 50% hike is pretty jarring.
2022-12-19-008	I support an increase for the taxi drivers. The proposed fees look appropriate. I think the airport fee for one person should be 40.00 not 50.00. If there is an increase in fees I would like to see more professionalism from the drivers.
2022-12-19-009	I think they are good where they are. Not only because they are the only transpiration for the low income families, emergencys. What if they needed to go to the hospital and they don't have 10\$ for cab! If you are going to increase the fare, change it to charge by time.

Althought I think an increase would be fair considering the current economic situation, this price raise is quite steep. You have to put into account the people that have no stable transportation and that need to make it to and from work on days when it's -40. There's also parents that have taxis as their only source of transportation to bring their children to and from daycare on cold days where they need to make it to work/school. That's a quick \$40 a day compared to the usual \$24. The taxi companies have been insanely slow with responding to customers. Insane wait times for those who need to make it to work on time and constantly letting the phone ring before a representative finally answers, nobody will want to be paying \$10 a taxi ride for cabs that do not give fast and effective service. It takes anywhere between 2-5 minutes to get from A-B on light traffic days in our community. We already have people in our comminuty struggling with the high costs of groceries, now imagine them having to pay an additional \$20 to shop for their family. On warm days I don't see them having much customers as people would want to be walking rather than paying that price and that will hit them even more.

#### **TOPIC**

## **Contracting of Vending Machines in MSC**

#### **BACKGROUND**

The Town received a request to operate vending machines located in the MSC.

There has been some discussion by previous Councils regarding what should be sold in vending machines within Town facilities. For the past number of years, the current vending machines have not been utilized and prior to the pandemic a number of them were in requirement of repairs but the cost to have them fixed was unreasonable and at the time prior to the pandemic there was the option to purchase items at the concession. This option is not available currently.

#### **FINANCIAL IMPLICATIONS**

Should the Town wish to contract out the vending machine operations there would be a positive cash flow to the Town however that amount would have to be decided later so exact implications are not known. Investigation would be completed first to see how it is handled in Hay River and at the Inuvik airport to gauge a price for space rental.

#### STRATEGIC PLAN OR PRIORITIES CHART IMPLICATIONS

This item is not on the strategic priorities plan or chart.

#### OTHER CONSIDERATIONS OR OPERATIONAL IMPACTS

Administration contacted several communities to ask whether they had any policies regarding vending machines and in particular what type of product can be sold.

Hay River – Their vending machines are contracted out to Territorial Vending who is based out of Yellowknife. Territorial Vending said there are no policies or restrictions in place, but they do try to maintain mostly healthy options in their machines.

Aklavik – The contact at the Hamlet office said they don't have vending machines in their buildings. When asked if she knew about vending machines in any building in the village and she responded that she doesn't think there are.

Tuktoyaktuk – They were supposed to call back and let us know if they had any. As of January 6, we have not had a response.

Fort Smith – They were supposed to call back and let us know if they had any. As of January 6, we have not had a response.

Should Council decide to have an outside organization be responsible for vending machines in a facility then it must be decided whether to enter negotiations with the person presenting the proposal or issue an RFP. Unlike our Procurement Policy there is nothing in our policies regarding accepting unsolicited revenue generating proposals.

#### **OPTIONS**

Council has several questions that must be asked before proceeding. They are:

- 1. Should vending machines be allowed in Town facilities and if so what facilities
- 2. If vending machines are allowed who should be responsible for them (Administration recommends it be an outside vendor)
- 3. Should the product type being sold be restricted

#### RECOMMENDATION

Administration recommends that approval be given by Council for Administration to enter into discussions with the person requesting to put vending machines into the MSC. Also that the current machines be scrapped or sold and should an agreement come into place the vendor would be responsible for installing new machines. The option of renting the current machines is not recommended due to potential issues should there be an issue with them.

This would require the following resolution:

"BE IT RESOLVED THAT the Inuvik Town Council approves Administration to enter into negotiations with Mr. Evan Lemieux regarding the vending machine proposal for the Midnight Sun Complex."

A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF INUVIK IN THE NORTHWEST TERRITORIES TO AUTHORIZE THE BORROWING OF TWO HUNDRED AND FIFTY THOUSAND DOLLARS (\$250,000.00) DURING THE CALENDAR YEAR 2022

**PURSUANT TO** the *Cities, Towns and Villages Act* of the Northwest Territories, S.N.W.T. 2003, c.22 as amended;

**AND WHEREAS** the Council of the Municipal Corporation of the Town of Inuvik may by resolution borrow such sums as the Town deems necessary in order to carry out its objectives;

**AND WHEREAS** the Town of Inuvik deems it necessary to borrow the sum of Two Hundred and Fifty Thousand Dollars (\$250,000.00) for the purposes aforesaid;

**NOW THEREFORE BE IT RESOLVED** that the Council of the Municipal Corporation of the Town of Inuvik, in Council duly assembled, enacts as follows:

- 1. The Town of Inuvik obtains a VISA credit facility for the sum of Two Hundred and Fifty Thousand Dollars (\$250,000.00) from the Canadian Imperial Bank of Commerce (CIBC) the purposes of enabling the Town to meet its expenditures.
- 2. These VISA facilities are to remain available for future borrowing until <u>December 31, 2023.</u>
- 3. The Town shall pay the Bank the monies so borrowed on demand and shall pay interest on said monies as remains from time to time unpaid.
- 4. Interest shall be calculated as per VISA cardholder agreement in effect from time to time both before and after maturity, default, and judgment, with interest on overdue interest at the same rate as interest on the principal. Interest shall be payable, monthly in arrears.
- 5. The Mayor and Senior Administrative Officer of the Town are hereby authorized and directed to execute and deliver for and on behalf of the Town such promissory note or notes as the Bank may require to evidence and secure payment of the monies so borrowed together with interest as described above.
- 6. The Town pledges, charges and hypothecates to the Bank, as security for the said monies and interest as described above, all revenues from whomsoever due to become due and payable to the Town; but the Bank is not restricted to such revenues for the payment of the said monies and interest as described above nor is the Bank bound to wait for payment until such revenues are received by the Town.
- 7. Nothing in this resolution waves, prejudicially affects or excludes any right, power, benefit of security, by statue, common law or otherwise given or implied in favour of the Bank.
- 8. By-law 2674/BORR/21 is hereby repealed.
- 9. This by-law will come into effect upon the day of its final passage.

- 2. All sums borrowed pursuant to the authority of this by-law, as well as other sums borrowed in this year from the said bank for any or all purposes mentioned above shall, with the interest thereon, be a charge upon the whole of the revenues of the Municipality for the current year and for all preceding years, as and when the revenues are received.
- 3. The Senior Administrative Officer is hereby authorized and directed to apply in payment of all sums borrowed as aforementioned, together with interest thereon, all the monies hereafter collected or received, either on account or realized in respect of taxes levied for the current year, preceding years, or from any other source which may lawfully be applied for such purpose.

## A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF INUVIK IN THE NORTHWEST TERRITORIES TO ESTABLISH WATER AND SEWER UTILITY RATES

**PURSUANT TO** the *Cities, Towns and Villages Act* of the Northwest Territories, S.N.W.T. 2003, c. 22 as amended:

**WHEREAS** the Council of the Town of Inuvik deems it desirable and necessary to establish a separate water and sewer utility rates by-law that can be easily amended from time to time;

**NOW THEREFORE BE IT RESOLVED** that the Council of the Municipal Corporation of the Town of Inuvik in Council duly assembled enacts as follows:

#### 1.0 SHORT TITLE

1.1 This by-law may be cited as the "Water and Sewer Utility Rates By-law."

#### 2.0 **DEFINITIONS**

- 2.1 In this by-law, the following terms shall have the following meanings:
- a) "Council" means the Council of the Municipal Corporation of the Town of Inuvik.
- b) "Customer" means a person(s) or a business, government or institutional entity receiving water and/or sewer service from a public Town owned water and/or sewer main.
- c) "Dwelling Unit" means a building, a self-contained portion of a building, or a suite of rooms for the use of one or more individuals living as a single housekeeping unit. A dwelling unit contains sleeping, cooking and separated or shared toilet facilities and is intended as a permanent or semi-permanent residence.
- d) "SAO" means the Senior Administrative Officer of the Town of Inuvik or their designate.
- e) "Town" means the Municipal Corporation of the Town of Inuvik.
- f) "Water and Sewer Utility Rates" means the schedule of rates, as amended from time to time and shown as Schedule A attached to and forming part of this by-law.

#### 3.0 GENERAL

- 3.1 Water and sewer customers will be billed for water and sewer services on a monthly basis at the first of each month, as per Schedule A, parts I and II, attached to and forming part of this by-law. Billings are due and payable within thirty (30) days of the billing date.
- 3.2 If any provision or part of a provision of this by-law is declared by court or tribunal of competent jurisdiction to be illegal or inoperative, in whole or in part, or inoperative in particular circumstances, the balance of the by-law, or its application in other circumstances, shall not be affected and shall continue to be in full force and effect.
- 3.3 In the event of any conflict between any provisions of this by-law and any other by-law heretofore passed, the provisions of this by-law shall prevail.

The increase in fees was included in the approved 2023 Interim Operating budget.

## A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF INUVIK IN THE NORTHWEST TERRITORIES TO ESTABLISH A SOLID WASTE LEVY

**PURSUANT TO** the *Cities, Towns and Villages Act* of the Northwest Territories, S.N.W.T. 2003, c. 22 as amended;

**WHEREAS** the Council of the Town of Inuvik wishes to raise revenue to offset the costs of its solid waste collection and disposal operations;

**NOW THEREFORE BE IT RESOLVED** that the Council of the Municipal Corporation of the Town of Inuvik in Council duly assembled enacts as follows:

#### 1. SHORT TITLE

1.1 This by-law may be cited as the "Solid Waste Levy By-law."

#### 2.0 **DEFINITIONS**

- 2.1 In this by-law, the following terms shall have the following meanings:
- a) "**Dwelling Unit**" means a building, a self-contained portion of a building, or a suite of rooms for the use of one or more individuals living as a single housekeeping unit.
- b) "Duplex" means two dwelling units sharing a common wall, and located side by side or one above the other.
- c) "Apartment" or "Apartment Building" means a residential land use consisting of at least three dwelling units with shared entrance facilities.
- d) "**Town**" means the Municipal Corporation of the Town of Inuvik in the Northwest Territories.
- e) "Council" means the Council of the Municipal Corporation of the Town of Inuvik in the Northwest Territories.

#### 3.0 APPLICATION

- 3.1 The Town is authorized to levy a charge of fifteen dollars (\$15.0015.50) per dwelling unit per month on all Residential buildings containing ten (10) units or less.
- 3.2 The Town is authorized to levy a charge of one hundred and thirteen dollars (\$113.00117.00) per month for 6.0 cubic yard bins and/or eighty-eight dollars (\$88.0091.00) per month for 4.5 cubic yard bins in Residential (11 units or more), Institutional, Commercial and Industrial Zones.
- 3.3 All levies include one pick-up per week. Additional bin pick-ups are available at a fee of twenty-eight dollars (\$28.0029.00) per pick-up.
- 3.4 All charges will be levied at the same time as the monthly charge for water/sewer services provided by the Town.
- 3.5 Application for bins can be made at the Town for Residential (11 units or more), Institutional, Commercial and Industrial users.

#### 4.0 REPEALS

By-law 2677/UTIL/22 is hereby repealed.

## Director of Public Works Monthly Report for December 2022

During the month of December 2022, the public works department had various projects and tasks that were completed or are ongoing.

- The Utilidor crew has had another busy summer, we have had to deal with dirty raw water this spring and now that we are in fall and the river has iced over the raw water turbidity has dropped to the wintertime level and makes for much longer filter runs before backwashing. The focus in the winter is to keep the water tempered so we can treat it and have our distribution system work well.
- In December even with the colder temperature's things were going pretty well until Dec 24<sup>th</sup> at about 2 pm when we were called to use our steamer to thaw out the GNWT water main and sewer main that runs from the Junction-32 to the hospital Nurses Resident. At 6.30 Christmas morning after all night streaming and 2 water pipe repair clamps they had it up and running. Normally we do not do this but both plumbing shops with steamers didn't have their units up and running Because this is a private water main, we will be billing the GNWT for all the work our guys did as well as all the parts we supplied. We had 2 other sewer main backups both cause by large amounts of grease and hand wipes.
- We did have to shut the water main on Franklin down to replace a nipple under a C.C. stop but we were able to get the replacement done in a real short time period.
- We have had a project for putting a third heat exchanger into the water treatment plant and up grades to the existing pumps at the power plant to use more waste heat from the Power Corp and this is now completed. We are using the waste heat recovery system from the Power Corp to heat the water treatment building as well as to temper the building. All seems to be working well!
- We had the roads graded to get rid of the snow that had accumulated over the month of December.
- We have had to do a lot of sanding of the streets this month.
- We have had a verry good 2022 and our systems are all working well!
- Electric power produced by the solar panels at the Town Hall and the Midnight Sun Complex. These are some of the things that happened during the month of December, as well as our usual jobs and everyday duties involved in running the Town's Public Works Systems.





Peace Officer Firth spent a number of days single handedly delivering hampers that were undelivered during the initial run.

Beyond supporting the human members of our community, the majority of time was focussed on rehoming a number of animals in our care. This has been an extremely difficult task over the past 6 months, as Southern Shelters have been overwhelmed by intakes and are unable to take northern dogs. Due to this limitation, the pound remained at capacity, with several dogs being in custody for over 100 days. This, in addition to picking up stray or aggressive dogs, restricted our ability to intake surrenders. This situation has not changed in the new year and we do not anticipate a great degree of movement in the near future.

3 taxi complaints were submitted, which were investigated and addressed.

Peace Officer Waighorn has submitted his resignation as he has been a successful candidate for a position with Parks Canada as a Park Warden. He has been with the department since 2019 and has

consistently delivered proactive, pragmatic and respectful services. We wish hm well. As part of succession planning, processes are already in play to appoint the existing casual animal attendant into a permanent Peace Officer role.
